

Olathe Public Schools Transportation Guidelines and Parent Signature Form

The purpose of this form is to review the Olathe Public School's transportation policy. Parents are asked to review the information, complete the appropriate section and sign the form. This form should be returned to the teacher, coach or activity sponsor.

Guidelines for District Provided Transportation

The district makes every effort to provide transportation for field trips and district athletic/activity events. In most situations, the district provides transportation to/from athletic and activity events however, there are circumstances in which the district does not provide transportation and the parents or guardians of the students assume responsibility for providing transportation for their students. The primary modes of transportation are school bus, district-owned vehicles and, in rare cases, teacher-owned automobiles.

There are circumstances in which the district does not provide transportation and the parents or guardians of the students assume responsibility for providing transportation for their students. These circumstances include, but are not limited, to the following:

- The district may not provide transportation to activities/contests that take place within the boundaries of the Olathe School District. In most cases, these events take place in the evening or weekend and the trip does not originate at the school.
- The district may not provide transportation to activities or contests that take place outside the Olathe District boundaries but are geographically close to the participating Olathe school. In most cases, these events take place in the evening or weekend and the trip does not originate at the school.
- The district may not provide transportation to certain athletic practices that occur off campus.
- The district does not provide transportation back to campus after practices that occur off campus.
- There may be other activity-specific reasons that preclude the district from providing transportation.

Students are required to use district-provided transportation for all field trips and athletic/activity events unless they receive approval from the school administration or their designee in advance of the activity.
